

## SUBOA Meeting June 2010

## Monday, June 14

Meeting called to order 8 am – Nick Lyons

- Introductions- Matt Hammill. NACUBO
  - o Need for SUBOA to be better engaged at National level.
  - o IRS has increased focus in many areas such as compensation, non-related business, independent contractor classification, etc.
  - o Studies/Research including endowments, debt management, energy and sustainability, HR issues, CFO census (demographics, responsibilities).
  - o Common topics need for greater flexibility and accountability. Need to understand what has worked in other states. Maryland and Virginia as examples.
    - Need to discuss next steps. (ACTION REQUIRED)
  - o Interest in budget & planning best practices.
- Budget Update Pat Ryan
  - NO BUDGET 2 months late. Threat of shutdown.
  - o SUNY still has appropriations through June 30. BUT, if OSC is closed, no way to process PO's and/or payments.
  - Fee Policy SUBOA needs to review and make final recommendation. (ACTION REQUIRED)
  - College Fee. Need to discuss where this belongs and how it should be used. (ACTION REQUIRED)
  - Starting July 1, we could be on a week-by-week emergency spending allocation. Need to provide response with any exceptions.
- Continued discussion on centralizing police chiefs. SUBOA needs to take a strong position. SUBOA to draft response based on the position paper drafted by SUNY Police Chiefs Association. (ACTION REQUIRED)
- Audit Mike Abbott
  - o Cleary Act. Have been campus visits and will be more.
  - o IT Security. New joint agency on Cyber Security. Will provide recommendations including controls and education.
  - Draft Audit Plan. Financial management, cash, payroll, IT. Procurement reviews based on data mining tool.
  - o OSC Audit. No communication received.
  - o Expenditure unit will continue audit including procurement transactions.
  - o Elevator maintenance contracts have been under review. See attached recommendations.
- SUCF Via Nick Lyons. Change to minor rehab, renamed to Critical Maintenance. Expanded scope, all projects must address critical maintenance. Maximum has been increased from \$100,000 to \$150,000.

- SUNY Systems Administration Budget. What is happening at Systems? \$15M in 1990 (would be \$30M adjusted). Was \$16.2M before cuts. Massive cuts being made. More after 12/31.
  - Campus issues with impact.
  - Funding for Systems is almost all State and any cut is permanent.
  - Details need to be communicated including service levels expectation. (ACTION ASK MONICA)
  - Outplacement is being provided.
  - Funding model needs to be part of the Budget Task Force discussions.
- Early Retirement. 12,600 are eligible including 3,900 faculty. Open period July-September does not work for SUNY. Guidelines will be provided after Board approval.
  Part A will go through 12/31. Vacancies can be used, if they occur, as part of the savings.
- o Need draft now. (ACTION REQUIRED)
- o A refresh of succession plans should be considered as this will become an issue at many campuses.
- o Contract with Inside Higher Ed for all SUNY campuses with unlimited postings.
- Faculty Workload. See handout. SUNY retains right to maintain/control components (teaching, research, community, etc.). Spring semester will become a challenge as there are less people. May need to adjust professional obligations.
- o Professional Employees. MOU covers this as a self-initiated process.
- SASA Update Mark Scott (Geneseo) and Pat Heath (Delhi)
  - See handouts.
  - o Contract renewal expires on June 30, 2011. Should provide more flexibility.
  - o ACS's looking at how to support the SUNY strategic plan (big 6)
